#### 1. PRELIMINARIES

- 2.4 For decision: recommendation to appoint The Chair and Treasurer as trustees (i) in whose names the assets of the Association will be held in trust; (ii) in whose names the accounts provided by VA Accountancy may be signed off in trust for the members of the Association; & (iii) in whose names ( as trustees acting on behalf of the members of the Association) VA Accountancy may request sign-off of any Corporation Tax assessments, whether £zero or greater. Agreed.

### 3. MATTERS ARISING

3.1 Approval of the previous minutes. The draft minutes were circulated and read out line by line. They were then agreed/signed without any amendments. Members noted that the version of the constitution

downloadable from the Association's website pre-dated the version agreed in minutes, and asked the Committee to remedy this. Members further noted that there had been a request for the Committee to try to disaggregate financial data for each allotment site, and a short paper or note from the Committee on its practicality or otherwise, would be welcome at the next AGM.
